# Being Christ's Hands in the World... [no excuses!]

Hosts of Convention: St. Mark's, Hood River

Presiding: The Rt. Rev. Bavi "Nedi" Rivera, Provisional Bishop

### Friday, October 1, 2010

Friday events were held at St. Mark's. Registration was held from 3:00-6:45 p.m. in the chapel. A soup supper was served by the people of St. Mark's in the parish hall from 4:30-6:30 p.m. The annual meeting of the Eastern Oregon Episcopal Foundation preceded the Convention meetings at 3:30-4:30 p.m. in a meeting room at the school district office located across the street from the church. The parish coordinators for Episcopal Relief and Development met with Diocesan ERD Coordinator, Bruce Barnes, from 4:30-5:15 p.m in another room of the school district office. The Foundation Trustees met following the Foundation annual meeting.

## Opening Session

A song practice led by Bishop Nedi preceded the opening of Convention. She spoke to choosing music for Convention with the plan of introducing new music that might be used in the parishes.

At 7:00 p.m., the opening session of Convention convened in the nave of St. Mark's. Bishop Nedi Rivera opened Convention by welcoming attendees to Convention and introducing the Rev. Anna Carmichael, Rector of St. Mark's. Anna welcomed the people to Hood River and to St. Mark's and thanked the people of St. Mark's for their work and hospitality.

Bishop Nedi explained that singing and silence would mark the liturgies of Convention. She explained that silence was a way to allow space in otherwise busy lives.

#### Session I: Build the Church

Bishop Nedi explained the activity for the evening. Participants were invited to "build the church" in small groups using legos, tinkertoys, and other building toys. After a period of time for building, there was time for each group to talk about what they had built and why. Groups then divided with half of the group staying and the other half moving to another table. The people who stayed were asked to welcome the newcomers and explain their building. The newcomers were instructed to offer ways to make the building better.

At approximately 7:30, participants gathered again in the nave of the church. Bishop Nedi asked for comments about what they might have discovered was important to them. A few of the responses were: open doors; it doesn't matter what it looks like; it doesn't need to fit together; the smaller the number of toys, the more conversation.

Announcements were made and Convention Committee Chairs were introduced.

## **Worship**

At 7:50 p.m., St. Mark's parishioners Julie Davis and Ruth Tsu led the gathering in Compline. The meeting recessed following Compline.

# Saturday, October 2, 2010

Saturday and Sunday sessions were held at the Best Western Hood River Inn.

## <u>Worship</u>

Convention reconvened in the Columbia Room of the Hood River Inn at 8:30 a.m. Bishop Nedi introduced keynote speaker, Sara Miles, St. Gregory of Nyssa Episcopal Church, San Francisco, author of "Take this Bread" and "Jesus Freak." She presented Sara with an Ascension School cross and explained that Sara would lead a "paperless" Morning Prayer.

At approximately 8:50 a.m., Sara Miles presented the keynote address. She spoke of her conversion experience after walking into St. Gregory of Nyssa out of curiosity. She stated that she took the breaking of bread and sharing literally which led her to start the Food Pantry. Food is distributed from the middle of the sanctuary of St. Gregory's. She spoke of Communion breaking open a space to do God's work. She said that the body of Christ takes form in the "most inappropriate people;" that regular people can be empowered to do Jesus' work. She made the point that the connection between church and outreach is "liturgy" which means the "work of the people." She stated that the "inconvenient truth" is that Christian life is a physical life; we are Christ's body and Jesus hands over authority to anyone willing to suspend self-doubt and to hear and act on His words. She ended her presentation with the words, "go and do likewise – no excuses." Questions and answers about the Food Pantry followed her presentation.

#### **Business Session I**

At 9:30 a.m., Bishop Nedi called the business session to order and asked Terry Joakimides, Secretary of Convention to report on quorum. Terry reported a quorum in the lay order and in the clergy order, and that all parishes were represented.

Bishop Nedi introduced and thanked Vicki Kelsey, Chair of the Host Committee, and again thanked the people of St. Mark's for their work on Convention.

Bishop Nedi read a letter of greeting from Mary Margaret Davis, Province VIII coordinator for National Episcopal Health Ministries (NEHM). It was noted that the Diocese of Eastern Oregon does not have a NEHM representative and the Bishop stated that anyone interested could contact her.

Bishop Nedi requested Convention to grant seat, voice, and vote to the Rev. Katy Anderson, ELCA Pastor/Rector of Hope Lutheran/All Saints Episcopal, Heppner. It was so moved, seconded and passed on voice vote with no dissenting votes.

#### **Transitions**

Bishop Nedi introduced new clergy to the diocese and reviewed transitions in the diocese since the 2009 annual Convention.

Bishop Nedi introduced Ray Jeff Sprier, Trinity, Bend, as a postulant for the priesthood.

# Episcopal Relief and Development (ERD)

Bruce Barnes, Diocesan and Province VIII Episcopal Relief and Development Coordinator, was called upon to give a report to Convention. Bruce reported on his travel to Belize to see the work of ERD and the effects of microloans for small businesses. He noted that donations to ERD continue to increase. He thanked the parish ERD coordinators.

### Ecumenical Ministries of Oregon (EMO)

David Leslie, Executive Director of Ecumenical Ministries of Oregon, was welcomed and invited to speak to Convention. David extended greetings from EMO. He spoke about the needs within communities saying that the number of homeless children has increased, and that the needs of homeless and poor continue to increase. He also spoke of divisions in mainline churches and decreasing donations to congregations. He spoke of the hope that we have as we work and live with questions of how to respond in a way that says "no excuses" to the communities we live in.

David spoke about the Healthy Kids initiative saying that Ecumenical Ministries of Oregon is actively recruiting congregations to become Certified Application Assistance Organizations to help families in local communities through the application process for Oregon Healthy Kids insurance program.

He also extended an invitation to the annual Collins Lecture: "Who is our Neighbor? Imagining Beyond Borders," to be held in Portland on November 18. David thanked the Rev. Jim Mosier and the Rev. Dcn Stephen Schafroth for their work on EMO boards.

#### Ascension School Camp and Conference Center

Patty Olson Lindsay reported on the summer season at Ascension School and ran a slideshow about the camps. She reported that campers were involved in outreach projects and support of the Millennium Development Goals. She told stories of campers' realizations that their actions can make a difference. Later in her report she read an article from the La Grande Observer titled "Source of Pride" which commented on the summer program and the outreach efforts of the campers.

Patty reported on finances at Ascension and distributed reports. She commented on and thanked the parishes for the amount of funding given to send children to camp. She also noted that Ascension continues to struggle and is in "the red" for 2010. She reported on being part of the Episcopal Camps and Conferences Association and the amount of good support and information offered by the organization. She asked for continued prayers and support for Ascension School and thanked the School Board and Cove coordinators.

## **Resolution for Canonical Changes**

Jim Foster, Chancellor, **moved** the resolution for Canonical changes as found in the Pre-Convention Journal. The motion was **seconded**. Terry Rahmsdorff reviewed the changes to the existing Canons and fielded questions. Jim reviewed the new disciplinary Canon that would take effect July 1, 2011. The motion **passed** on voice vote with no dissenting votes.

# Resolutions Referred to Dioceses from the 76th General Convention

As required by General Convention, Secretary of Convention Terry Joakimides read the proposed Constitutional Amendments to Article I.4, Article II.2, and Article VIII.

Bishop Nedi explained that the reading of these proposed amendments is intended to give people the opportunity to talk to their General Convention deputies about the amendments before they are passed at a second General Convention.

### 2010 Proposed Budget - First Reading

At 10:35 a.m., following a break, Diocesan Treasurer Jerry Frazier presented and reviewed the proposed 2011 budget as distributed at registration. Under income, he noted the increase in requested grant from Eastern Oregon Episcopal Foundation Remington fund for retired clergy medical insurance. He also noted the contribution/subscription line for Communications and the funds (lines 23-26) from which monies could be taken to balance the budget.

Following Jerry's review of expense line items, there was a time for questions and discussion. It was noted that the references on lines 120 and 122 needed to be changed to line 62 and line 64 respectively. Patty Olson Lindsey spoke to the Ascension School Support line item stating that the 2010 expense would be over by about \$15,000. In response to a question about income from property sales, Jerry noted that the Vale property could be sold as well as property in Arlington and Klamath Falls. It was clarified that no funds have been borrowed, nor is there any longer intent to borrow from Eastern Oregon Episcopal Foundation for funding the bishop's position.

Jerry introduced and thanked the Finance Committee: Kenneth Leibham, Arnold Coe, and Edd Doorn.

#### Report of the Task Force on Diocesan Futures

The Rev. Chuck Christopher presented a report on the work of the Task Force on Diocesan Futures. The report outlined the history of the diocese's reliance on funding from Coalition 14 and subsequently Domestic Missionary Partnership. Chuck also outlined assumptions upon which the Task Force has agreed and the functions of a diocese. He commented that the steps outlined are being done concurrently and that the calendar and functions of the Task Force can be found on the website. A written report was distributed following the presentation and is an addendum to this document.

### Bishop's Address

At 11:30 a.m. Bishop Nedi presented her Address to Convention. She began by commenting that it was wonderful to be at her second Convention of the Diocese of Eastern Oregon. She noted that she has worshipped in all but two of the congregations and has visited and seen each of the congregations. She stated that it is a privilege, honor and joy to serve with the people of Eastern Oregon and noted that the whole church is looking at the futures of the diocese.

The text of Bishop Nedi's address will be found following these minutes in the pages of the Convention Journal.

### <u>Worship</u>

The Rev. Dcn Michelle Meech and Kathy Macek led Noonday Prayer. Following worship and announcements, clergy spouses convened for lunch with the Rev. Bob Moore, spouse of Bishop Nedi, in the Garden Room of the Hood River Inn. Lunch was served to Convention attendees in the Gorge Room of the Hood River Inn.

# **Workshops**

At 1:15 p.m., Sara Miles offered a workshop in the Columbia Room about the Food Pantry. At 3:00 p.m., the Task Force on Diocesan Futures offered a workshop in the Columbia Room. Concurrently, Bob Thomson offered two workshops in the Riverside Room on parish websites and technology options for disbursing information.

# Worship

At 4:30 p.m., Convention reconvened in the Columbia Room for Evening Prayer based on Holden Evening Prayer and Evening Prayer in the Lutheran tradition. Worship was led by Lowry Browning, St. Paul's Worship Leader. Jerry Frazier and Pastor Katy Anderson read the lessons. Convention recessed following worship.

# **Banquet**

Convention Banquet was held at 6:00 p.m. in the Gorge Room of the Hood River Inn. The Rt. Rev. Rustin Kimsey was asked to offer grace before the meal. Jeanie Senior, Sr. Warden, St. Mark's, acted as emcee. Entertainment was provided by a Chamber group comprised of Marjorie Rosemont, Roxanne Shoemaker and Nancy Roudin performing a Giuseppe Verdi piece in three movements.

Following the entertainment, Jeanie commented on Millennium Development Goal #1: Eradicate extreme poverty and hunger. She stated that the ingathering would go to Episcopal Relief and Development for microloans. Baskets were passed to collect the ingathering.

The Rev. Anna Carmichael thanked the people of St. Mark's for their work on Convention and presented a bouquet to Vicki Kelsey for her work as chair.

Patty Olson Lindsey presented the Ascension School banner to St. Paul's, The Dalles, for their fundraising for scholarships that allow children to go to camp. She presented the Ascension Cross to Bob Thomson for his work on technology at Ascension, his work on the School Board, and his support of Ascension School. Bishop Nedi announced that Thanksgiving Dinner and Advent Retreat would be offered at Ascension School if there was enough interest expressed by October 20.

# Sunday, October 3, 2010

The meeting was reconvened at 8:25 a.m. with Bishop Nedi leading the singing of "Let the broken ones be healed." Morning Prayer was led by Victoria Kelsey, St. Mark's, Hood River, and other members of Daughters of the King.

### **Business Session II**

The business session was convened at 8:45 a.m.

It was **moved**, **seconded and passed** on voice vote to cast a unanimous ballot for **Robert "Bobby" Fox**, Bend, and **Ruth Tsu**, Hood River, in the Lay Order, Class of 2013.

#### Reports

Bishop Nedi announced that reports could be found in the Pre-Conventon Journal and will be filed by title.

She called upon The Rev. Dcn Michelle Meech, Director, Center for Anglican Learning and Leadership (CALL), Church Divinity School of the Pacific, who spoke briefly about the program offerings and availability of information. Michelle also thanked the Diocese for their support during her seminary education.

# **Budget Second Reading**

Jerry Frazier moved the budget as presented. The motion was seconded. Discussion followed.

Arnold Coe, Cove, moved to amend the budget to add \$10,000 to line 59, Ascension School support and \$10,000 to line 70, Bookkeeping/Payroll/Administration. The motion was seconded and passed on voice vote with dissenting votes.

Discussion continued on use of funds to balance the budget. Fred Bierig, Nyssa, **moved** to amend the budget to use property sales funds to balance the budget if necessary. The motion was **seconded**. Discussion continued. Rustin Kimsey spoke to going back to General Convention to ask for some base budget support to be restored. The motion **passed** on voice vote with dissenting votes.

Bishop Nedi called for vote on the amended budget. The motion on the amended budget passed on voice vote with no dissenting votes.

Jerry Frazier thanked the Finance Committee and Tiiu Vahtel, Business Manager, for their work on the budget. Applause followed.

### **Courtesy Resolutions**

Chair of the Resolutions Committee Julie Sarazin, Nyssa, presented the Courtesy Resolutions report. The resolution for greetings was amended as follows and **passed** on voice vote with no dissenting votes.

# Report of the Convention Offering Committee

Chair of the Convention Offering Committee, the Rev. Dcn Ruth Brown, Redmond, **moved** that half of the Convention offering go to the outreach choice of St. Mark's, Hood River, and that half of the Convention offering go to Ecumenical Ministries of Oregon for the Healthy Kids Program. It was stated that the choice of St. Mark's was Episcopal Relief and Development for microloans. The motion **passed** on voice vote with no dissenting votes.

Leslie stated that the Millennium Development Goal focus for 2011 will be #4 – Reduce Child Mortality. She stated that the ingathering at the 2011 Convention will go to Episcopal Relief and Development in partnership with the Episcopal Diocese of the Dominican Republic and Clinicia Esperanza y Caridad, an Episcopal medical clinic located in the city of San Pedro de Macoris.

## Resolution on Open Communion

Bishop Nedi asked for a vote to bring to the floor a resolution on Open Communion proposed by Trina Sherman, Ontario. The Bishop noted that there must be a two-thirds majority. Approval was given on voice vote with no dissenting votes.

## Trina Sherman moved the following resolution:

Be it resolved that the Diocese of Eastern Oregon propose a resolution to the General Convention [Committee on Liturgy and Music] striking the rubrics limiting the distribution of the Eucharist.

The motion was **seconded** and discussion followed. It was **moved**, **seconded**, **and passed** on voice vote with no dissenting votes to amend the resolution as noted in parentheses above.

The Bishop explained the process for a resolution proposed to General Convention. She noted that it could take more than one General Convention to approve such a resolution. Scott Cooper, Prineville, questioned whether this resolution could jeopardize our relationship with the ELCA. Pastor Katy Anderson, Heppner, indicated that she did not believe that it would. The Rev. Paul Morton, Redmond, commented that there could be unintended consequences in regard to the theology of Baptism. Ty Lavender, Ontario, asked about possible effects on the relationship of The Episcopal Church and the Anglican Communion. Bishop Nedi

acknowledged that it would be difficult for the resolution to get through the House of Bishops but that it was worthy of being put on the table.

The motion **passed unanimously** on voice vote. Bishop Nedi appointed the Rt. Rev. Rustin Kimsey, the Rev. Anna Carmichael, the Rev. Christy Close Erskine, and Trina Sherman to a committee to write the theological rationale and background for the resolution.

# **Closing Business**

The Rt. Rev. Rustin Kimsey asked to make an announcement. He commented on the life and recent death of the Rev. Ray Ferguson, friend of the Diocese of Eastern Oregon, former Vicar of St. Alban's, Redmond, and brother of the Rev. Larry Ferguson. He asked for prayers for Ray Ferguson's wife, Louise and their daughters.

Rustin then commented on the rebuilding of the Cursillo program in Eastern Oregon. He announced the dates for Cursillo weekend and asked for prayers for that program.

Following other announcements, Bishop Nedi adjourned Convention at 10:05 a.m.

## **DIOCESE OF EDEO CONVENTION ADDRESS 2010**

# Being Christ's Hands in the World ... [no excuses]

Grant us, Lord, not to be anxious about earthly things, but to love things heavenly; and even now, while we are placed among things which are passing away, to hold fast to those that shall endure; through Jesus Christ our Lord, who lives and reigns with you and the Holy Spirit, one God, for ever and ever. Amen.

#### The Desert

We were tightly packed into some kind of jeep, borrowed from the Red Cross. It was hot. The road was nothing more than a worn part of the desert. Our driver was a farmer. She said that's how she knew how to drive dirt roads with huge ruts and deep puddles.

The road seemed never ending and it was really bumpy. It was not and there was no air conditioning. We learned that in this part of Mexico, the drug dealers run the desert Monday through Thursday. If you want to cross the border without having to carry drugs, you need to try to cross on weekends. Fernando had called ahead and they knew we were coming. So we weren't in any danger.

Finally we stopped in the road behind the water truck. We piled out, squeezed between the strings of barbed wire that marked some boundary and walked a few yards to a big blue barrel set on a small saw horse that reminded me of a Christmas pageant manger. While a brother bishop brought the hose to the barrel, Fernando took the duct tape off the top of the barrel and unscrewed the bolts that held a rectangular lid over an opening. We filled the barrel until the dust floating on top of the old water was skimmed off the top through the overflow hole. We replaced the lid and sealed it with fresh duct tape.

Then we stood in a circle and reflected on all we had heard and seen that morning, particularly, what we were seeing there, right next to THE FENCE. Miles and miles of fence sometimes made of wood slats; mostly made of various kinds of wire mesh. We were at a water station in Mexico. There in the desert it was too hot to stand too close to one another. There was no real shade, and although I've done some pretty long distance walking, I knew there was no way I could survive this trip.

I reflected on Moses and the Israelites: forty years in the desert. God provided water for them – water from a rock. Fernando was being Christ's hands in that desert. Twice a week he brings water to God's people, God's precious children.

The desert is a beautiful place, and the desert is a dangerous place. Later that week Bob and I worshiped at a gorgeous, huge, well-to-do southwestern adobe church. There were notices on the outside doors reminding people to keep them closed because there were snakes about.

Dangerous. Easy to get lost. It's hard to get your bearings with so much flat land. Distances are hard to judge and if you are coming from afar, like New Englanders coming

to Oregon, you have no comprehension of these vast open spaces. We learned that once the immigrants made it safely over the border they were often disappointed to learn that they were hundreds, or even thousands of miles from their destination. Some had been told that Chicago was just *over the border*.

Dangerous. You will meet strange beasts. And you need a quart of water per hour. You don't really want to sleep on the ground, (scorpions as well as snakes), and as hard as it is to believe when it's 110 degrees, it can get pretty cold at night.

In Scripture the desert, the wilderness, the wilderness, is central to the story of the people of God, and it is key to Jesus' story.

The people of God, as I said earlier, had been led out of slavery seeking God's Promised Land. They left behind (as they reminded Moses more than once) leeks and onions and cucumbers. The only thing they had to eat in the desert was manna – that *stuff* that appeared every morning and turned to maggots if you hoarded it; that *stuff* called "What is it?" Stuff they tired of eating but stuff that sustained them.

They looked forward to, when they could believe the promise, of a land flowing with milk and honey, but they had trouble believing it.

They complained a lot. Murmured and mumbled against Moses and his leadership. Once, you'll remember they got tired of waiting for him to come down from the mountain – he'd been up there for ages (receiving the Ten Commandments as it turns out) – so they gave up on him and his God.

They convinced Aaron, Moses' older brother, to help them create an idol. An idol like all those *other* peoples had. A god you could see and touch . . . instead of a God who could hear, see, touch and care about them. They created the Golden Calf and began to dance and party and worship the god they had created . . . instead of the God who created them.

The desert. It's not an easy place. It's too easy to get lost and distracted.

For Jesus, it was no less dangerous, no less difficult. But partly because it was forty days, not forty years, and even more, because Jesus knew deep in his being that it was the Spirit who had driven him there, the desert experience was, for him, defining. It was the place where he learned what it means to be the Son of God, God's beloved, God's chosen.

Jesus learned that it didn't mean power over creation, nor was it a ministry of satisfying everyone. It didn't mean acceding to the lies of the Evil One who claimed lordship over the world, nor did it mean personal security, fame, glory nor ministry based in one's own ability. Rather, the desert was a place where he learned that his ministry was about deep, deep trust in God, being at one with those he was called to serve, and proclaiming the truth, that is first and foremost proclaiming the good news of God in Christ – the Kingdom of God has come near!

## Being in The Wilderness

Of course, you know where I am going with all this.

We too are in our own desert. A time when we can be tempted to believe that we are in a barren place. A place with few or no recognizable resources. We have left the known world of business as usual, but we don't yet know where we are going. We are between what was old and what is new.

We have some time in the desert while we prepare to enter our promised land. And it may be flowing with milk and honey, or it may be inhabited by giants. Or both.

But here's what I know about the desert.

God is in the desert. It is a holy place. Jesus has hallowed it with his presence and prayers. It is a holy place, where the Israelites, led by a pillar of fire by night and a pillar of cloud by day, finally came to know God was with them and providing for them: Manna and water stations filled twice a week. God is in the desert.

God is in our wilderness too. God is with us in this journey into the unknown. God offers us our own manna, our own water stations and it is the Spirit who has led us here. So what does it take to make this journey from slavery to Promised Land? How do we move forward?

# **Journey**

First, we have to leave Egypt. We have to throw off the shackles *and* we have to leave behind, for the time being anyway, leeks and onions and cucumbers. When immigrants leave Oaxaca, they leave the poverty, the hopelessness and the violence, but they also leave their homes, their language, their families – parents, spouses, children. They hope someday to return as new people, or to send for their families, or to help their families by sending back checks, but first they have to leave.

The story of the Exodus is formational for Jews and Christians. It teaches us something central about the life of faith. This story reminds us that faith is a journey. That life is leaving, repenting, letting go.

I have travelled thousands of miles in the short time I have been with you. I have worshiped in all but two congregations and visited every town where I am called to go, and I hear two things that I think we need to let go of: we need to let go of our nostalgia for the good ol' days and we need to let go of our sadness or anger about the hurt we have endured.

And perhaps, although I don't hear this often explicitly, but I hear it just under the surface, we need to let go of our sense that somehow we didn't, don't or won't measure up to some standard we have set for ourselves. That maybe we are to blame for having to be in the desert.

We need to forgive.

Others (to be pointed, especially) those who were called to lead us, who we believe failed us, and we need to forgive ourselves for calling them or for our part in letting the relationships break down, or for not loving them very much. We need to forgive the world, as Jesus did, not knowing what love we have to offer, and to forgive ourselves for failing to love ourselves, one another and the world as Christ has loved us.

#### Pillar of Fire

Forgiveness is, my friends, our pillar of fire. Forgiveness is how we will be led through the desert in the dark night of our souls, both personally and corporately. Forgiveness is the hard work of being Christian and living in Christian community.

When I told someone that I wanted us to spend some time on forgiveness this weekend they said to me, "But we've done that already." ...

One of the most helpful things I have learned about forgiveness is the seven times seventy rule. You remember Jesus telling Peter he had to forgive not seven times seven but seventy times seven. I used to think that Jesus was telling me I had to be a doormat. But now I don't think so. I think Jesus is telling me that every single time a grudge rises to the surface, every time I'm tempted to rail against a certain former president, every time I start to tell someone about how they *always do something wrong*, I am called to forgive. The same old stuff again and again – not because they *are always doing the same thing wrong*, but because once again I have picked up the garbage can and stuffed all thirty-three gallons of old stuff in my backpack.

I'm not suggesting letting someone walk all over you, that's not forgiveness, that's allowing bad behavior. I'm talking about the stuff in the past that bogs us down and makes it difficult to move forward.

We are in the redemption business. Forgiveness is not only our pillar of fire, it is our vocation. Forgiveness is how we are transformed, made new, resurrected. We forgive Pharaoh not because Pharaoh is sorry, or because Pharaoh didn't know, or in spite of the fact that Pharaoh doesn't have a clue about why he needs forgiveness. We forgive because we need to let go of the chains that bind us to the past, to hurt and to death.

#### Pillar of Cloud

So having let go of what we no longer need, we look to the promise. We have been set free for a purpose. We are set free so that we can once again become the people of God. So that we can be Christ's hands in the world. That means the Pillar of Cloud is Jesus' ministry of compassion.

The land of milk and honey is that place where we discover that life has its greatest meaning when God's love is moving through us. How many times have you, like I, done something grudgingly, because you knew you *should* only to discover that you have been bathed in Grace. A few weeks ago I found myself being the 'celebrity reader' at our local

Episcopal church literacy program. I pushed myself out of the house in the midday sun, went to a place where there were a dozen I didn't know and to have some conversation and read a couple of chapters of the Boxcar Kids. I haven't had that many loving hugs in a long time, and one of the kids told me I was a really good reader. Just a short afternoon offered and I walked with a lilt in my step the rest of the day.

When we were at the border in Arizona and Sonora, over and over we were overwhelmed by the stories of brave and gracious people, and then we were thanked *for just being present*. I was kicked in the rear by God as I listened to Chris, the border patrol agent, speak of rescues in the desert, and how he would change our immigration policy and also his profound thank you's for just listening to his side of the story.

Over and over Jesus says, "You want the kingdom of heaven? Then, Follow me." Get over yourself and be my hands in the world. Feed the hungry, give water to the thirsty, clothe the naked, visit the prisoners, welcome the strangers – and through all this, not as a reward, but as a result of your compassion -- "inherit the kingdom prepared for you from the foundation of the world."

<u>Missional Rennaisance</u> reminds us that we are called into the world, to be Christ's hands and feet and voice and arms. We have learned that our congregations can and do make a difference in our communities, but sometimes we get sidetracked thinking that building the church is building the kingdom. We know better, but we forget.

We have been forgiven, healed, renewed, restored, redeemed so that . . . so that, empowered by the Holy Spirit, we can be Christ's hands in the world. Our congregations are about ministry. I love it when I see the community gardens, the bulletin boards with pictures of your partners in ministry in Haiti, Honduras, El Salvador, and in the cities in which you serve. I love hearing about the food kitchens, pantries, Friday Bible Schools, prison ministry. These will lead us to the Promised Land. This is the Promised Land.

#### Manna & Water from a Rock

The desert is dangerous. The wilderness is vast. But God is there.

God is *here* – leading us with the pillar of cloud by day and the pillar of fire by night. Providing manna to eat and from a rock, water to drink. We live by the grace of our sacramental life together and Jesus' self-giving life, death and resurrection.

The desert is where we will come to know who we are and who the Diocese of Eastern Oregon is called to be and become. How will we be the people of God? What partners will we need to respond to God's call to our diocese? What structures do we need to support one another and to receive faithfully the gifts God pours down upon us? Can we stop asking the consumer question of what do we 'get' for our assessment, and ask the Jesus question of what do we have to share with one another? How in our sharing will we "strengthen for service the hands which holy gifts have taken?"

There is discernment to be done, listening to the Holy Spirit in the midst of two or three or more gathered together in Jesus' name. The Commission on Ministry will in the next year be helping us become a people of discernment – which is different from decision making, and essential to it as we move into an unknown future.

We like to think of ourselves as poor, isolated and misunderstood. But the incarnation and Jesus' ministry, and the lives of the saints tell us something different. We are the beloved children of God and we are blessed by an abundance of gifts from the living God who sends a Son who lays down his life for his friends.

We need to give up the murmuring and mumbling. Let us look to those whom we are called to serve and remember how much we have, how deeply we are loved.

Tomorrow morning we will conclude this convention with the Eucharist in which will receive so many of God's gifts for the journey.

We will receive the forgiveness of sins, as we ask God to "renew a right spirit" within us. Perhaps we will also forgive ourselves, let go of regrets and trust God who redeems everything, absolutely everything – our sins, our best intentions, our good deeds gone awry, our broken hearts.

Trusting in God's power to bring new life out of death, we can forgive those we need to forgive – whoever it is that we are called to love as Christ loves us—laying down our lives for our friends, and loving our enemies (because we know that retaining sins is keeping us shackled in slavery.)

We will once again receive the joy of baptismal waters and the opportunity to reaffirm our promise to follow Jesus.

We will in holy communion with God and one another, receive the body and blood of Christ, given food more miraculous than manna and wine more refreshing than water in the desert.

And, you will have the opportunity to have your hands anointed with the oil of chrism – as a sign that Christ (the Anointed One) has no hands but ours with which to heal a broken world.

We have all that we need ... and more. What else can we ask of God?

May these signs and all the signs of God's love and presence with us, nourish us in this time together and in shared ministry in the Promised Land.

#### 2010 Ascension School Report

As I considered what to write for my report on Ascension School I looked back to last year's goals. In those goals I talked about making Ascension School more sustainable and increasing programming. I'm happy to report that we have increased our programming options and have a rough draft of 2011's schedule ready. We are also gaining a better understanding of what it will take financially and programmatically to make Ascension School more viable and financially sustainable. Diocesan Council has recently given Ascension School the go ahead to begin planning for an Annual Giving Plan, which we feel is an essential piece for the success of our camp and conference center. Diocesan Council will need to review and approve the plan to determine how to proceed.

The 2010 Visioning Retreat, led by Tom Cashman, was a great success. We came out with clear objectives and who would take the lead on those objectives. We have programming, funding and maintenance objectives that we will be working on over the course of the next two years. The Visioning Retreat objectives and strategies will be available at Ascension School's Convention booth.

Our outside and diocesan rentals continue to be an important part of our ministries here at Ascension School. Our rentals didn't decrease this year but the numbers of people attending decreased. I do think the economy has affected those numbers. We distribute evaluations at the end of each event and feedback on events and rentals remain positive.

Bob Thomson, Ascension School board member and the chair of the Communications Committee, will be updating Ascension School's website to incorporate a "Conference Center" site and to bring a continuous look to our site that will match the Diocesan site. Keep your eye out this fall for our new look, <a href="www.coveascensionschool.com">www.coveascensionschool.com</a>. These kinds of improvements will help with our communication and marketing.

#### Summer Camp 2010, To Love and To Serve

Another great camping season came to a close this summer. The kids had an amazing summer connecting with each other, our wonderful earth and our communities. The campers participated in many activities this summer designed to teach them about what it means to love and to serve.

#### Some Activities Included:

Greetings from the Youth and Family Ministries program at Trinity in Bend.

I am beyond thrilled to be reporting to you on the status of our programs. There is a lot of activity surrounding the start of our 2010/2011 program year and the excitement is palpable.

Aside from moving into my office and settling in a bit, my first activity in this position was to attend the planning session for the Provincial Youth Event in Salt Lake City. One of our high school youth, Savannah Stalker, and I traveled to SLC and met the amazingly well-oiled machine that was in place as the Design Team: Kathy Hamilton, Fr. Earl Gibson, Karl and Katie Akesson, Alison Lehner, Alex Kirkorian, and Greg Tuttle. We spent three days working through the agenda and details for the gathering, which was to be held July 19-23.

Upon my return, I assisted with editing the registration materials and the Facebook page. I made contact with our Diocese about getting the word out for scholarships for attendees, and called or e-mailed parishes to encourage participation. With that, we had only one youth sign up with another possible in the wings. That would have brought our Eastern Oregon contingent to four – which beats the zero number of attendees since 1999.

Unfortunately, registrations were slow and the Provincial Leaders made the decision to cancel the event.

We will request that the unused funds (approximately \$4,200) be allocated to encouraging Diocesan attendance at the Episcopal Youth Event (EYE) June 22-26, 2011 in St. Paul, Minnesota. EYE attendees are also of high school age, and with some earlier promotion about the event, we should be able to encourage more attendance.

Meanwhile, efforts were focused on providing Godly Play start-up support to other congregations. A Godly Play CORE training was set up in cooperation with the First Presbyterian Church here in Bend. Information was sent to the Diocese to encourage participation. Follow up with several congregations was made. The training took place August 13 – 15 with attendees only from Trinity and 1<sup>st</sup> Pres. We intend to continue to build our support base here together with the intention of helping other congregations in our respective areas.

Last Spring, Marsha Landrith of our Lakeview congregation visited our Godly Play program leaders. In July, Stephanie Hicks and Gail McGuire traveled to Lakeview to give a presentation and Q&A session for both the Episcopal and Presbyterian congregations

there. The two came back with the wonderful idea to provide videos to congregations that will demonstrate the stories and film sample Q&A sessions so that interested folks can view them at their leisure. Convening a group over this topic has proven difficult, yet maybe the flexibility of video can help spread the word. We will begin this project with the start of the program year.

In other news, we confirmed three youth members on Pentecost. A new Wednesday afternoon program began June 2 – the Family Kitchen Prep Squad. Our J2A Pilgrims had a successful trip to Ireland. Plans for full Sunday Morning Education Classes, Youth Group gatherings, and an Adult Education – Parenting Track are falling into place. We are also making plans for a youth mission trip to Condega, Nicaragua and an "urban immersion" trip to Los Angeles – both for the Summer of 2011.

We, of course, welcome involvement in any of our programs, whether it be as a participant or an information-gatherer or both! We look forward to keeping interested parties informed via email, Facebook (TECBend for Youth and Trinity Episcopal Church - Bend, OR for general news) or snail mail.

#### **Education for Ministry**

EFM is a four year program covering the Hebrew Bible, the New Testament, Church History and theologians and philosophers. Currently, we have one EFM group up and running in Pendleton, with another taking root in Central Oregon, which will begin in September of 2010.

Because of our distance from educational opportunities, member of our diocese have taken advantage of EFM for their foundational learning when in discernment about the deaconate or the priesthood. For others, it has been a vehicle to enhance and deepen their personal ministry, allowing them to become more deeply involved in their parish and also in their wider community.

The opportunity to do theological reflection in community is invaluable in shaping those who may be isolated in a small place. And now that EFM is available on-line, those members of our diocese who cannot find a face-to-face EFM group will be able to access a group wherever they may live. I will be involved in co-mentoring an on-line group in the fall, and hope to recruit people in that situation.

Those who have taken advantage of this excellent program have benefitted from our Diocesan support. Even with that support, however, EFM, it is a costly program. It is \$350 a year, which can be aided with scholarship funds. The program without diocesan sponsorship would be \$460 a year, so it is important to the continuation of EFM in the Diocese of Eastern Oregon that the program continue to be sponsored.

## Episcopal Relief and Development in Eastern Oregon

I have served as Episcopal Relief and Development Diocesan Coordinator for our diocese the past 9 years, and continue to be excited and impressed by the tremendous work of Episcopal Relief and Development in our world. And I am equally excited and impressed by the response of our diocese to the ongoing calls for donations which make possible this critically important work. Literally hundreds of lives have been saved and improved over these 9 years by the donations from our diocese alone. In 2009, we gave \$32,752 to Episcopal Relief and Development, a bit less than in 2008 but significant considering the worsening economy in 2009. We are one of the few Episcopal dioceses with ERD Parish Representatives active in every congregation, and I am grateful and appreciate the work they do.

This past May I had the opportunity to attend a Network Meeting in Belize for Episcopal Relief and Development. It was the first time that this meeting was held outside the U.S., to give the diocesan coordinators a chance to visit ongoing community development projects funded by Episcopal Relief and Development. Belize in many ways is typical of the 46 countries currently served by ERD. It is a very poor country, and is also one where the Anglican Church has taken on many programs to serve those in need regardless of their beliefs or affiliations. The Diocese of Belize provides 22 schools throughout the country, including a large high school in Belize City. We visited two schools, including a class for deaf children, and a school without a supply of clean water. We also visited three small successful businesses started by a micro-loan program, including a farm, a wood-carver, and a small store. I came away from that trip with a deeper appreciation of what it means to live in abject poverty in a country where abject poverty is pervasive, where you and your family don't have enough to eat, and neither do your neighbors. And I came away with a more personal understanding of how much can be done with very little money to give people hope, health, and self-esteem.

Episcopal Relief and Development is a major means through which we are the hands of Christ in the world, serving those most in need. We are Episcopal Relief and Development; without our donations its work would not happen.

Dear Diocese of Eastern Oregon,

Thank you so much for the grant of \$1423 you have given to Alpha Communities Mongolia to help with our work among pre-primary children in one of the most poverty-stricken districts of Ulan Bator. As you know from the material sent, the meals the children receive at our kindergartens are their only regular nutritious meals, and the curriculum prepares the children for success in their subsequent schooling.

Imagine my shock when I first found out that children could fail the first grade in Mongolia and be through with their schooling before they had really even started. Children from families who could not afford the state run kindergartens just didn't seem to stand a chance against those who already knew the alphabet, some basic math, and could even read simple stories. What chance of any kind of future did the unprepared children have, except for a future scraping a living off the streets? Not only do the children who attend our kindergartens grow up strong physically through the good meals and regular health check ups, but they have also proven themselves to be well prepared for schooling, with a failure rate of nearly zero, and many excelling beyond all expectations.

It has been one of the great privileges of my life to have made a difference in so many children's lives, and with them, their families' lives, and I appreciate your support both financially and in prayer.

## Eastern Oregon Haiti Project

Objective: Improve educational opportunities for children in Cap Haitien, Haiti so that they will be able to contribute to the sustainability and vitality of their country.

Thanks to the generosity of the Diocese of Eastern Oregon, the people of St. Paul's The Dalles, and the hard work of many volunteers involved in fund raisers, St. Paul's will be sending two teams to Cap Haitien in January 2011.

The educational team will be observing and modeling in schools and will provide professional development workshops to help teachers improve their teaching skills. The educational team will also be working to train Haitian literacy coaches to provide ongoing support for the teachers. The literacy coaches will receive advanced training from the team and will also be provided scholarships to attend the International Reading Association conference in Orlando. In addition the team will purchase quality children's books for the library and provide professional books for the teachers.

The medical team will do well child check-ups and immunizations. They are consulting with the Colorado Haiti Project to learn what is needed most acutely.

This is a long term project with many smaller projects and objectives as well as the main projects. A relationship with Cap Haitien priest Fr. Noe Bernier has been established. Fr. Bernier visited with the team and St. Paul's in August.

The Eastern Oregon Haiti Project is still seeking volunteers. In particular they need trained medical personnel and experienced elementary teachers, especially those who have experience conducting professional development workshops.

Report to the 40<sup>th</sup> Convention of the Diocese of Eastern Oregon Bisbee Grant Funded Program to Feed the Hungry by St. Paul's, Klamath Falls in Partnership with First United Methodist Church

St. Paul's Klamath Falls started helping First United Methodist Church with their Tuesday night feed the hungry program in September 2009. Initially the Methodists were doing dinners every Tuesdays by themselves. Now St. Paul's and other church and community groups provide meals each Tuesday.

The Methodists put out a 'Free Dinner Tonight' sign, and we feed whoever comes through the door. This includes many street people, young teens out of their homes - in Klamath Falls we have between 300-400 youth who sleep on the street every night - elderly, young mothers with children and others.

After the Methodists had been running this program themselves for several months, they decided to offer a Tuesday to other churches, and civic groups. At present Sacred Heart Catholic Church, The Friends Church, the Klamath County Democratic Party, and St. Paul's serve meals each month with the support of the United Methodist Church.

We were asked to join a year ago September. We have 15 members of St. Paul's who help on a regular basis. We set up around 3 pm and start serving at 5 and are usually cleaned up and out by 7pm. Each person is assigned a task and given space to complete it. The Methodist kitchen is well equipped with good serving and work space.

During the school year the Methodists have an afterschool program with two retired principals and several teachers to tutor students, help them complete their homework, and work on several computers. The church also gives each child a snack. The children leave about 4pm and many will come back with their families to have dinner.

We enjoy our customers. They not only come in hungry, but when they leave will stop and tell us thank you and how much they enjoyed their meal.

The church is in an ideal position to create this program as it is in the middle of down town and near to the school. It is also only three blocks from St. Paul's.

We thoroughly enjoy getting to know the members of the Methodist Church and are privileged to share with them in their outreach into the community.

When we first began our dinner night we served between 50 and 75 meals. In the last three months the head count has increased to 130. If we have leftovers that do not keep well, we donate them to the Klamath Gospel Mission to help them with their outreach feeding program. We are developing dinners that are easy to serve, high in protein and fresh fruit and/or vegetables. We serve milk, coffee, tea, lemonade and water. In cold weather we also serve coffee and hot chocolate.

Our costs are between \$150 and \$200 each month depending on what we serve and what parts of the meal are donated by members. St. Paul's members have donated goods ranging from paper goods to desserts.

We so appreciate the \$2,000 grant given for this outreach program from the Bisbee Fund. It has made it much easier for us to serve good, hot, nourishing meals for those who have so little.

## Bisbee Grant report for Helping Hand, Pendleton

Helping Hand is a jointly operated program of the Church of the Redeemer, United Methodist Church, 1<sup>st</sup> Presbyterian Church, St. Mary's Outreach, and the Community Action Program of East Central Oregon. The 2010 grant was originally for purchase of food supplies for the pantry, but was amended this summer with approval of Diocesan Council to allow some of the funds to be spent for emergency housing for clients.

The pantry as of August this year has served 176 households for a total of 477 individuals. With the Bisbee funds the program has purchased cereals, canned vegetables and fruit, sauces and pastas, meats, margarine, and children-friendly soups. The program was also able to provide through other funds and sources hygiene products, diapers, an additional wide variety of donated food items, and fresh bread.

In addition, we utilized funds to provide emergency rental assistance for 3 households with 13 individuals, including 4 children under the age of six, 4 school-age children ages 7-18, and 5 adults.

With the recession experienced in Eastern Oregon, we have seen many new faces needing food and emergency services. Thank you so much for this gift.

On behalf of the Sunriver Christian Fellowship, especially the Up Close and Personal (UPCAP) Ministry, we thank you for the 2010 Bisbee grant we received. The grant award of \$2558 was to provide:

- Additional milk for our monthly Care and Share Program
- Emergency Assistance to families in poverty, or financial crisis with basic food, clothing, shelter, utilities, transportation and medical support.

In 2010 the Bisbee grant funds have provided:

- \$1000 for additional milk for an average of 191 families per month through the Sunriver Care and Share Program
- \$1558 for Emergency Assistance for 14 families, with 29 children, providing clothing, rental and utility assistance, funds for gas and driver's license renewal, and medical expenses. (If you want specific details on these expenses they are available for your review.)

The current economic crisis in Deschutes County, and particularly southern Deschutes County, our area of service, has created a demand for services, unparallel in recent history. With the unemployment in our area above 14% many families are struggling, many have declared bankruptcy, lost their homes, and live on the edge or in poverty. Your support of our Outreach and Up Close and Personal (UPCAP) programs has been deeply appreciated. Together we continue to spread the Good News of God's grace and love.

I will be offering Education for Ministry for the 12<sup>th</sup> year at Eastern Oregon Correctional Institution in Pendleton beginning in September. The six men in the class will all be graduating from Year 4 next spring, making a total of 20 inmates who have completed all four years. Because of financing, and because I feel it is time to step down, this will be my last year of mentoring EFM at the prison.

Two inmates who completed all four years of EFM and have since been released from prison, have kept in contact with me. One of them is attending college, maintains a 4 point and is on the Dean's List. The other is working at his previous job, and is reportedly doing very well. Both of them attribute part of their success since their release to their participation in the EFM program. Another inmate who completed the program tells me that he is able to stay in touch with God since he completed EFM.

In addition, I continue to offer a monthly communion service, as well as special services on Christmas and Easter at the prison.

I appreciate the opportunity I have been given to reach out and serve God in this way.

#### Roanridge Grant – Seminary Intern Program

Thanks to a generous grant from the Roanridge Trust, The Diocese of Idaho and the Diocese of Eastern Oregon formed a partnership to jointly sponsor and administer an internship program for the summer of 2010. Originally we imagined the program would offer a summer internship placement for three seminarians. We expected those seminarians would have completed their middler year as that is often a time for exploring new possibilities and ministries. Much to our surprise not one seminarian responded to our invitation. The good news is we had several other possibilities presented. As a result we had not three but four interns. Two were recent seminary graduates. Another is currently a candidate for priesthood in the Diocese of Idaho who is attending classes offered through the Diocese of Utah as well as locally. The fourth is in aspirant for Holy Orders and is finishing his final semesters of college and planning to apply to be a seminarian next year.

Two of those persons served as Camp Chaplains. One served at Paradise Point the camp in the Diocese of Idaho and one at Ascension School in the Diocese of Eastern Oregon. This was the first time either of our dioceses had an intentional, full-time, chaplain and we found them to be invaluable assets to our campers and resource staff. Aside from providing spiritual formation and guidance they were able to provide basic structure for the worship life of camp. Our camp directors are enthusiastically requesting we seek ways of continuing this ministry for and with them in the future. We are partnering with the Diocese of Idaho in applying for a DMP grant to continue and expand this ministry as well including additional dioceses in the partnership.

The other two interns had varying responsibilities through the summer. Idaho's other intern participated in a dual project this summer. One of those was to do an ethnographic study of the area where an older, established, but diminishing congregation is located in a mid-size Idaho community. He additionally served as a resource staff person in a migrant labor village in Idaho. He was also instrumental in organizing and staffing a camp specifically designed for Latino families for whom English is a second language.

The fourth of our interns served as a resource staff person at Ascension school and has offered worship leadership in various of our congregations in northeast Oregon.

While the program evolved into something quite different than we expected it was a wonderfully challenging experience that has moved us to think in new directions for the future. The grant stimulated the emergence of a strong partnership with the Diocese of Idaho. Additionally, it has helped us see the wisdom of including persons in the discernment process as potential interns. We expect to partner with the Diocese of Idaho in applying for another Roanridge Trust grant to further the internship program and, hopefully, to expand it in future years.

## Standing Committee 2010 Annual Report 40<sup>th</sup> Convention of the Diocese of Eastern Oregon

This year was the first full year that the Standing Committee served with Bishop Rivera. Our primary function by canon is to serve as the Bishop's council of advice and serving in that capacity with Bishop Rivera has been a pleasure.

We spent much of our meeting time revising our letter of agreement with Bishop Rivera following her resignation as Suffragan Bishop of the Diocese of Olympia. The agreement provides for her serving the Diocese of Eastern Oregon one third time, about eight to ten days a month. We have had several discussions clarifying our expectations for her ministry with us so that we have concrete objectives on which to base a mutual ministry review with her next year.

Those goals are:

<u>Development of Diocesan Models:</u> Bishop to facilitate with the Futures Committee the development of various models for the future operation of this Diocese.

**Goal:** Bishop and Committee to present to 2011 Convention 2-3 models for Diocese future and their anticipated annual financial costs.

<u>Congregational Development:</u> Bishop to facilitate local parish examination of their ministries and their impact on their local communities and explore other models of being a congregation in community.

Goals: By February 2011, the Bishop will have assigned clergy oversight to every congregation in the Diocese and by Pentecost 2011 every congregation have a plan for their future development.

<u>Ministry Development:</u> Bishop will work with the Commission on Ministry to clarify its role and responsibilities in the recruiting and development of professional clergy for the diocese as well as providing support and development of ministries of the baptized. **Goal:** By June 2011 the Commission on Ministry will have goals, objectives, and strategies to meet their objectives

**Resource Development:** Bishop will help facilitate the development of best practices for Diocesan personnel and financial management and will also help in the development of stewardship initiatives.

**Goals:** By Convention develop a set of standards in compliance with National Church standards for the annual review of all Diocesan employees. Identify both internal and external opportunities for stewardship including grants, internal financial and energy efficiencies.

We approved the deposition of two members of the clergy who had resigned their orders.

We discussed to possible sale of the property of the former Trinity Church in Vale.

We recommended the Rev's William Robert Totten, Jim Mosier for ordination to the priesthood and Michelle Meech for ordination to the transitional deaconate.
