COM Report

IONA Initiative

Bishop Pat discussed the IONA Initiative that had been presented at the April Diocesan Council Meeting. The Commission on Ministry had sent a letter to Diocesan Council recommending the program for the Diocese and Marilyn Roth and Diane Adams had attended the IONA Conference in July to review programs and learn more about how it can benefit EDEO. EDEO will be combining resources with the Diocese of Idaho and possibly the Diocese of Utah which will help offset some of the costs of the program. In addition to IONA the hope is to offer access to the online program offered by Seminary of the Southwest. The program is scheduled to be implemented by the first of June 2018.

Financial Report

Diocesan Treasurer, Randy Heise led the discussion on the following financial issues.

Travel Policy update

The current travel reimbursement policy for volunteers in EDEO was reviewed. A committee was formed to create a new policy to present to Diocesan Council at the November Council retreat in Cove. The committee members are Randy Heise, Adrienne Brown, Mary Link, and Aletha Bonebrake.

M/S/C Motion to have EDEO cover the lodging costs of Diocesan Council members for the August 4-5 meeting. (Aletha Bonebrake, Mary Link)

Reimbursement Form

Council was given the EDEO reimbursement form with updated per diem amounts.

Diocesan Future Planning Committee (Financial Planning)

Randy reported that Finance Committee had recommended forming a committee to help with creating a Strategic Plan for the future of EDEO. Council discussed the formation of a committee or the possibility of hiring someone to facilitate a plan. The Council decided that the focus of the retreat in November would be strategic planning and other business would be handled via online meetings, dates to be determined.

2018 Budget

Randy presented the proposed 2018 budget. He is going to do some research regarding income from past years to determine if the proposed income is based on the 22.5 and the 25 percent assessment or just the 22.5 percent. Health care costs were also discussed and Aletha offered to work with Lisa on researching ways that the diocese could save money on those costs.

M/S/C Motion to approve the transfer of funds from the Ministry Development and Strategic Development

Funds to the operating fund for 2018 budget. (Vicki Mosier, Adrienne Brown)

M/S/C Motion to submit the proposed 2018 budget to Convention with an amendment to change line 22 from \$43,600 to \$45,000 which alters line 31 to read \$471,100.00 (Mary Lujan, Mary Link)

Standing Committee Report

Mary Lujan reported that Standing Committee had reviewed property issues and approved the ordination of Marilyn Roth to the priesthood on September 9th in The Dalles.

Ascension School Report

Kim McClain reported that there were 43 people at the Labor of Love weekend at Ascension School and 184

campers attended camp this year. The first backpacking camp was successful and they hope to expand on that

next year. Her goal, now that camp is complete, is to focus on marketing and future planning. She is still finalizing

the 2018 budget and is concerned by the number of maintenance issues and equipment replacements that have

occurred this year and how to plan for that in next year's budget.

Bishop's Report

Bishop Pat thanked Kim McClain for her hard work thus far in her position as Executive Director of Ascension

He updated council that former Ascension School Executive Director Patty Lindsey has accepted a School.

position as the new Executive Director of the Episcopal Service Corp.

The Bishop reviewed Project Resource and asked council to provide him with names of the people from the

diocese who would be interested in attending the conference in April of 2018. 2 Clergy and 2 Lay are eligible to

go. Several members came up with names and would be sending their contact information to the bishop.

There is a group of people that are working on proposal to form a congregation within the Snake River

Correctional Institute, as well as to expand on the ministries that are provided to the families of those who are

incarcerated. Such a plan would have to come before council and convention to be approved.

He spoke briefly about the ordination of Marilyn Roth and reported that Dan Lediard had resigned as rector of St.

John's in Hermiston. He is planning a Staff Retreat in September with Michelle Meech, to be held in Baker City

August 6-8, 2017.

Next year's Adult Education leader will be author Wendy Farley and the event will be held the 3rd weekend in

August.

The keynote speaker for the 2018 Diocesan Convention will be Stephanie Spellers, Canon for Evangelism in the

Presiding Bishop's office.
